Capital Assessments:

Checks must be made payable to HEPOA. Capital Assessments allow the POA to maintain and improve our community property.

Dryer Vent Cleanings and Chimney Inspections:

Bates Sales and Service and The Chimney Doctor are completing services this month. Your unit's reports are included with your monthly Statements.

Quiet hours and Security:

Quiet hours are from 10:30 pm until 8:00 am. Should security be called because of excessive noise, the first call is complimentary. Subsequent calls will result in a fine for the Unit Owner even if the noise is caused by a renter or guest. Security can be reached by calling 501-622-8247 or 501-622-5424.

LOADING AND UNLOADING:

Please be respectful of your neighbors who are loading and unloading their vehicles. Managing supplies and little ones can take time – be patient – and better yet – help out!

PROPERTY UPDATE:

Tennis and Pickle Ball Courts:

Weather in another state prevented Hellas Construction from beginning work on the courts in May. Our goal is to have all courts completed in early June.

Decking:

Deck work on Building 20 Red Bird is scheduled for September 11th. The process will take 6 weeks and occupancy is NOT recommended as construction hazards will be onsite. Building 8 will begin upon completion of Building 20, or the last week in October depending on the weather and will take 4 weeks to complete. Building 4 is scheduled to begin after Thanksgiving and will also take 4 weeks to complete. Natural State General Contractors takes great effort to pick up all excess materials such as scrap and nails daily, and our Property and Grounds Crew doublecheck their efforts.

Pools:

Chlorine levels are monitored daily. There is NO lifeguard on duty and no glass or pets are permitted in the pools. Please note the maximum capacity of occupants posted at the pool. Children under the age of 14 must be accompanied by an adult. Pool hours are 9:00 am until 10:30 pm. Security will be called if the pool is occupied after hours.

Firearms and Fireworks:

No discharge of firearms or fireworks is allowed. Violations will result in a \$500 fine to the Unit Owner, which may subsequently be charged to a guest or renter.

Trash:

Pick up of bagged household trash is provided by the POA on Mondays and Fridays. Bagged trash must be placed inside the trash bins. If you have extra trash that needs to be picked up, please call the office to schedule. **Please do not leave bagged trash outside the bins as critters LOVE to scavenge for food.**

Driving at Harbor and the Speed limit:

Driving on a narrow two-lane road can be challenging even during good weather. **Please STAY ON YOUR SIDE OF THE ROAD.** The speed limit is **20 miles per hour** with reduced speed on curves and narrow roads. Please make sure that young children are accompanied by a responsible adult while traveling on an ATV or on a Side-by-Side.
